## Carefully structured to be effective

What's more, for the most timely and strategic assignment of claims, we've structured our claim organization first and foremost by technical discipline, and then regionally or nationally, depending on the type of coverage or business unit involved. The Commercial General Liability and Auto claims are handled on a regional basis, while Specialty, Professional Liability, Property, and Workers Compensation claims are handled nationally, with more centralized oversight.

  - All outside legal invoices are systematically audited before adjuster approval

- Claim Quality
  - All Claim units are audited annually by internal claim audit team



### Commercial General Liability Claims

The Hanover's Commercial General Liability Claims are centralized into three regional teams located in Worcester (MA), Chicago, and Sacramento. Supporting these operations are approximately 75 claim professionals.

## Complex, Specialty or Professional Liability Claims

All complex, "specialty," and professional liability claims are escalated from the regional field offices to The Hanover's Major Case Unit or the Non-Medical Professional Liability Team. These two units consist of seven managers and approximately 35 claims professionals. The Major Case Unit is managed out of our Worcester headquarters, while the Professional Liability Management is centralized in the Chicago Claim Office.
